Other hazards not contributing to the classification	: This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels. If the product is handled or used at high temperature, contact with hot product or vapours may cause burns. Do not wait for symptoms to develop. Any substance, in case of accidents involving pressurized circuits and the like, may be accidentally injected under the skin, even without external damage. #### 4.3. Indication of any immediate medical attention and special treatment needed

Protective equipment	: Small spillages: normal antistatic working clothes are usually adequate. #### 6.2. **Environmental precautions**

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. 7.1. Precautions for safe handling	
Precautions for safe handling	: Ensure that all relevant regulations regarding handling and storage facilities of flammable products are followed.
