#### 4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. If there is any suspicion of inhalation of H2S (hydrogen sulphide). #### 6.2. **Environmental precautions**
