First-aid measures after inhalation

: In case of spontaneous vomiting, transport the victim to a hospital, to verify the possibility that the product has been aspired into the lungs.

: In case of disturbances owing to inhalation of vapours or mists, remove the victim from exposure; keep at rest; if necessary, seek medical attention. See also Point

First-aid measures after skin contact

: Take off contaminated clothing and shoes. Wash thoroughly with soap and water. If inflammation or irritation persists, seek medical advice. 4.2. Most important symptoms and effects, both acute and delayed

Symptoms/injuries after inhalation

: This product has a low vapour pressure, and in normal conditions at ambient temperature the concentration in the air is negligible. A significant concentration may build up only if the product is used at high temperature, or in case of sprays and mists. In these cases overexposure to vapours may cause irritation to airways, nausea and dizziness.

Symptoms/injuries after skin contact

: Prolonged and repeated skin contact may cause reddening, irritation and dermatitis, due to a defatting effect. Contact with hot product may cause thermal burns.

Symptoms/injuries after eye contact

6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. 6.3. Methods and material for containment and cleaning up

For containment

7.1. Precautions for safe handling

Precautions for safe handling
